

## LETTER OF CONSENT TO BE IN THE INET ACTORS AND STAKEHOLDERS DATABASE

## Background

European Forest Institute (EFI) is an international organisation established by European states, conducting research and providing policy support on forest-related issues, connecting knowledge to action.

EFI is coordinating INCREDIBLE, a project that seeks to establish Innovation Networks open to all those involved or interested in creating economic, social and environmental value through improved production, collection, processing, marketing of Mediterranean Non-Wood Forest Products (NWFPs). INCREDIBLE is funded under the EU Commission H2020 framework programme.
